Rights & Terms of Use

- I will only start the work after receiving 70% or more of the the total payment. The final art in high resolution and without the watermark will not be delivered until the totality of the payment is completed.
- This is a payment for goods and services which do not require shipping. The customer agrees and is aware that no physical copies are to be sent to them.
- These payments will not be refundable after they're done unless I'm unable to start the work within the timeframe agreed upon.
- Rights to use the art are granted upon receipt of payment in full, provided that payment in full is made within thirty (30) days after the completion date.

- The client may request a rush job on new and/or existing works, for an additional charge ranging from 25% more over the total price of the piece, to double the amount of the original price given depending on the urgency and type of job.
- The payment methods I currently accept are only through Paypal invoice and Payoneer.

- Previous to starting the work, if it's required depending on the nature of the project, the client must have read and agreed to the Licensing Agreement sent after discussing the project.

- You affirm that you are of legal age and have the power to enter a binding agreement with me, and are not barred from doing so under any applicable laws.
- Unless stated otherwise, when done the image the client paid for is only to be used for the time period and the products agreed on previously to the payment of the invoice.
- I, in no way, will take responsibility for the misuse of the images sent to me by the client. By indicating me which images/photos I should use, the client automatically claims that they are the owner of said images or have the permission to use them.

- On the preliminary stage, the client is going to receive 1-3 initial sketches as low resolution JPGs. Here the client has the opportunity to request changes to things like the layout,

composition, shape and size of the subjects, their placement, etc.

- After the sketch has been approved I'll proceed to add color and clean the drawing as required. This is the time to request changes such as darkening and/or lightening of a color, adding more highlights or shadows, etc.
- Unless stated otherwise previously to starting the piece, only four (4) corrections are to be allowed per artwork. If the client needs more edits than the ones agreed on previously, an extra will be charged according to the complexity of the edit. This might range from 1% of the total price of the project up to 25%.
- Timeframes for the project are to be discussed and agreed on previously to me sending the invoice for the payment.
- The final art will be sent as a high resolution, non-layered PSD, TIFF, AI, JPG or PNG file, depending on the client's needs.
- Referring exclusively to illustrated works: my signature should legibly appear on each product and packaging.

By sending the first half of the payment the client automatically agrees with these terms and conditions.
